PLEASE TAKE NOTICE that the undersigned counsel on behalf of the End-Payor Plaintiffs will move this Court before the Honorable Nina Gershon, United States District Court, Eastern District of New York, 225 Cadman Plaza East, Brooklyn, New York 11201, on a date set by the Court, for an order:

1. Adopting A.B. Data and Class Counsel's recommendations to reject the claims for which claimants have sought Court review;
2. Authorizing the payment of \$191,871.44 to A.B. Data accrued and future costs in relation to its work on settlement claims administration, the payment of which was not previously approved by the Court;
3. Authorizing the payment of \$98,304.02 to A.B. Data for costs incurred in preparation of sending notice of the Court's class certification order prior to settlement; and
4. Authorizing the distribution of the Net Settlement Fund to the End-Payor Class.

In support of this motion, End-Payor Plaintiffs rely on the accompanying memorandum of law, the declaration of Scott Grzenczyk and exhibits thereto, and any further reply submissions.

End-Payor Plaintiffs have submitted a proposed order with the motion.
