## **GERSHON, United States District Judge:**

On September 23, 2021, End-Payor Plaintiffs, on behalf of themselves and the End-Payor Class, entered a settlement with defendant Allergan, Inc. ("Settlement"). On January 18, 2022, I issued an order granting End-Payor Plaintiffs' Unopposed Motion for Preliminary Approval of Class Action Settlement, Notice and Claims Plan, and Plan of Allocation. Dkt. No. 716 ("Preliminary Approval Order"). 2. Opposition to any motion opposing a	
request for exclusion;	
3. Responses, objections, and/or	
oppositions to the motions for final	
approval, fees, reimbursement of	
expenses, and service awards; and	
4. Notice of intent to appear at the fairness	
hearing. <sup>2</sup>

memoranda in support of the Motion for	
Entry of a Set-Aside Order, the motions	
for final approval, fees, reimbursement of	
expenses, and service awards, and any	
motion opposing any requests for

Aside Order, the final approval motion,	
fee motion, and any motion opposing any

Class members to postmark date or file	August 11, 2022
